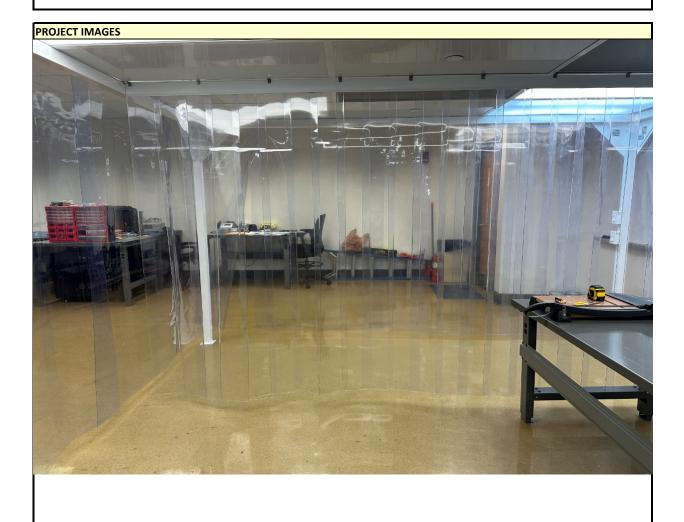

PROJECT DESCRIPTION: SOFT WALL CLEAN ROOM INSTALLED INSIDE EXISTING LAB ROOM 221 AT PARTNERSHIP 1, IN ORDER TO PROVIDE PARTICULATE CONTROL FOR THE AREA. NEW VAV INSTALLED, AS WELL AS SUPPLY AND RETURNS. TEST AND BALANCING PERFORMED. ELECTRICAL TIE-IN PROVIDED BETWEEN BUILDING ELECTRICAL AND SOFT WALL CLEAN ROOM FOR: POWER SUPPLY FOR INTERNAL CLEANROOM DUPLEX OUTLETS, HARDWIRED CONNECTION FROM CEILING ON SEPARATE 20A 120V CIRCUIT, POWER SUPPLIES FOR CLEANROOM FAN FILTER UNITS AND LED LIGHTS, EMERGENCY LED LIGHT WITH BATTERY BACKUP, AND POWER TO UPGRADED HVAC UNITS. EXISTING FIRE SPRINKLERS REWORKED TO ACCOMMODATE COVERAGE AROUND CLEAN ROOM ENCLOSURE. NEW TIE-IN PROVIDED BETWEEN BUILDING FIRE SUPPRESSION SYSTEM AND SOFT WALL CLEANROOM CONNECTION FOR INTEGRATED FIRE SPRINKLERS.
