PROJECT DESCRIPTION: TECHNOLOGY UPGRADES IN ROOMS 102, 103, A214, & 266 AT CREOL TO ACCOMMODATE THE INSTALLATION OF OIR-PROVIDED MULTIMEDIA EQUIPMENT. PDC SCOPE INCLUDED THE INSTALLATION OF FIRE ALARM RELAYS, ADA ASSISTIVE LISTENING SIGNAGE, AND THE REPLACEMENT OF CEILING GRID TILES IN EACH ROOM. ROOMS 102 AND A214 ALSO HAD PROJECTOR SCREENS REPLACED, DISCONNECT SWITCHES INSTALLED, WITH PATCHING AND PAINTING DONE AS NEEDED. CONDUIT AND PULL STRING INSTALLED BETWEEN ROOMS 102 AND 103.
