ALSO INCLUDES A LABORATORY FLOW METER, (2) TEMPERATURE GAUGES, AND (2) SHUT-OFF VALVES. DRYWALL CUT OUT, REPLACED, AND PAINTED FROM EXISTING PANEL IN 122 TO CEILING TO PROVIDE ACCESS FOR NEW 1/4" CONDUIT FOR SERVICE TO DISCONNECT IN 117. PAINTING DONE FROM CEILING TO FLOOR, CORNER TO CORNER. | |
