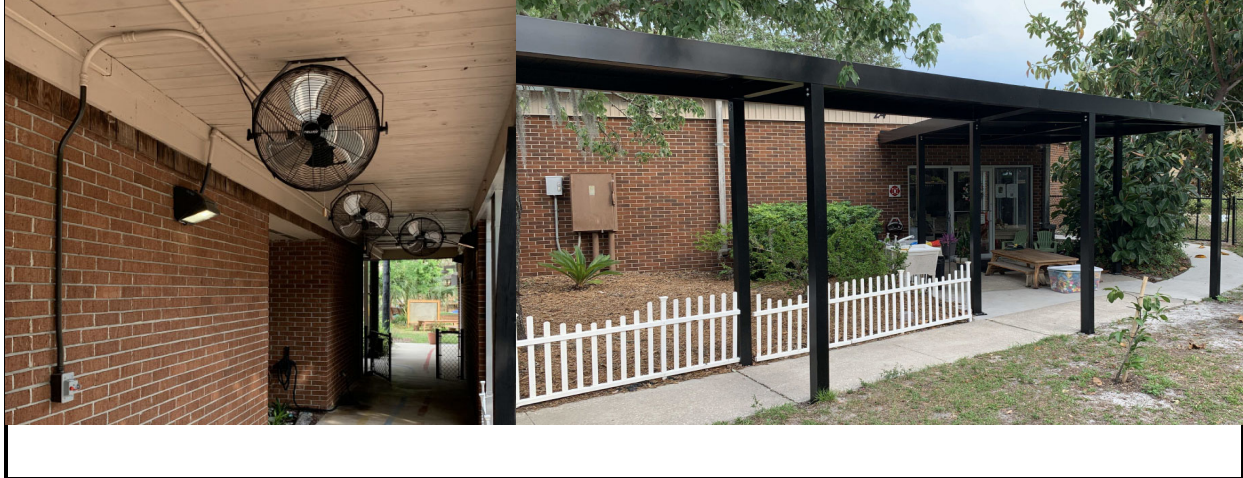

PROJECT DESCRIPTION: INSTALLATION OF 4 AWNINGS, 2 SHADE STRUCTURES, AND CEILING FANS AT CREATIVE SCHOOL 1. ONE 38' X 37' SHADE STRUCTURE WAS INSTALLED OVER AN EXISTING PLAYGROUND, AND THE OTHER 20' X 20' STRUCTURE INSTALLED IN A GRASSY PLAY AREA. EXTRUDED AWNINGS WERE ADDED AROUND THE BUILDING TO PROTECT CHILDREN FROM THE ELEMENTS. CEILING FANS WERE ALSO INSTALLED IN AN EXTERIOR CORRIDOR. PROJECT REQUIRED 7 DIFFERENT PERMITS, AND SEVERAL CHANGE ORDERS, AS DECISIONS WERE MADE TO ADD MORE AWNINGS.
