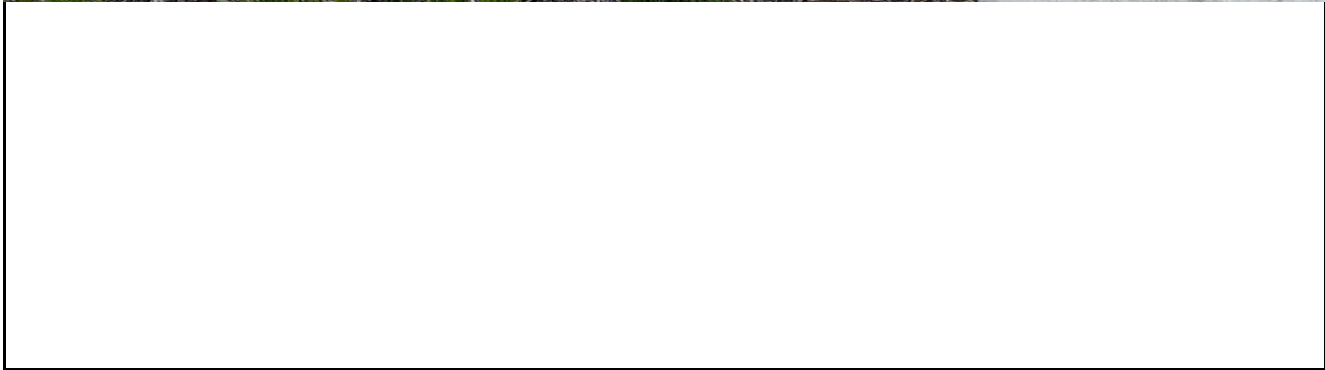

OUTLET LOCATED AT THE SERVICE PARKING SPACE ADJACENT TO THE PHYSICAL SCIENCES BUILDING, AND CONNECTED BY CONDUIT TO ELECTRICAL ROOM 142. PROJECT REQUIRED THE REMOVAL AND REPLACEMENT OF A 48" BY 60" SECTION OF SIDEWALK, AND PAINTING OF NEW PARKING LINES. WORK DONE BY UCF LANDSCAPE & NATURAL RESOURCES INCLUDED PLANT REMOVAL AND REPLACEMENT, AND RETROFIT AND REPAIR TO THE EXISTING IRRIGATION SYSTEM.
